

The **School of Public Health** at Bielefeld University seeks to appoint as soon as possible a:

Junior professor (W1; m/f/d) in Public Health with a focus on qualitative research methods

At Bielefeld University, scientists representing a wide variety of perspectives work together in an interdisciplinary way to promote innovative research and teaching at the highest level with an international orientation. Bielefeld University comprises 14 faculties including natural and technical sciences and medicine with about 3,500 employees and 25,000 students.

The future professor should represent qualitative research methods in research and teaching at the Bielefeld School of Public Health. The candidate should be able to connect with the scientific research of the faculty and be willing to cooperate with other faculties of Bielefeld University and external cooperation partners. Close cooperation between the School of Public Health, the newly founded Faculty of Medicine, other faculties (e.g. Sociology, Psychology and Education) and the Institute for Conflict and Violence Research (IKG) offers the possibility of inter- and transdisciplinary work at the Bielefeld location.

We are looking for a scientist:

- with a very good doctorate, preferably with a strong reference to qualitative methods, or a focus that combines the perspective of qualitative methods with public health
- who has developed their own scientific focus, especially in the areas of various methodological approaches of qualitative social research (qualitative content analysis and reconstructive social research)
- who has demonstrated their scientific-methodological and, if applicable, practical experience through relevant national and international scientific publications
- whose previous research work demonstrates the ability to conduct independent research in the field of the professorship at the highest scientific level
- who has teaching experience in university courses related to public health which have been positively evaluated.

Inter- and transdisciplinary cooperation experience as well as international cooperation and networks are desirable.

Recruitment for the advertised professorship is based on §36 HG NW. The appointment is at first limited to three years. An extension for another three years requires a positive evaluation.

Applicants whose first language is not German should be able to teach courses in German, in addition to courses in English, within about two years of hiring.

Bielefeld University has received a number of awards for its achievements as an equal-opportunity employer and has been recognized as a family-friendly university. The university welcomes applications from women. This is particularly true with regard both to academic and technical posts as well as positions in information technology as well as the skilled crafts and trades.
